



The Inn at Scituate Harbor Pool Parties

All function reservations and agreements are subject to the rules and regulations of The Inn at Scituate Harbor and they are as follows:

All pool party reservations are for a two hour period. A maximum of 10 children are allowed in the pool area. Two adult chaperones are required to oversee the party at all times.

Fees: A two hour Pool Birthday Party will cost \$150.00. This includes time to swim in the pool and have a birthday party - example: Pizza and cake at the party table. At time of reservation payment is expected in full. A \$25.00 cancellation fee will be assessed for a canceling the party at any time.

Defined area of use: For safety reasons, it is imperative that minors and or children are strictly supervised at all times. Children must stay in defined areas. Please ensure all children remain in the pool area and adjacent changing/locker rooms. Children are not allowed to be in the Pub, Inn lobby, and guest room areas.

Pool Rules: For your safety, and in order to comply with all local and state health regulations, please observe all pool rules and regulations that are posted in the pool area.

Lifeguards: The Town of Scituate does not require The Inn at Scituate Harbor to provide certified lifeguards at its pool. It is therefore the Patrons responsibility to provide oversight and regulate all activities in and around the pool area and maintain a safe and sanitary environment.

Pool Toys: Pool toys are allowed in the pool area. Please ensure they are clean and free of sand and dirt before bringing into pool area. We are not responsible for any damage or loss of pool toys.

Inn Provides: At your request we will supply two six foot tables for use in the pool area. Trash container is provided- however you must remove all trash and dispose in dumpster next to building. You are allowed to use changing areas, shower rooms, and bathroom facilities.

Towels: Please provide your own towels. All towels are to be removed at end of function.

Food and Drinks: Families are responsible for supplying their own paper goods, food and drinks. Food brought in cannot be homemade- it must be purchased from a bakery, restaurant or be a premade item from a grocery store. All food and beverages must be consumed at the provided tables. No glass containers are permitted. Only paper or plastic containers and serving items are allowed. No alcoholic beverages are permitted. The following food items are permitted- Pizza, Cake (not ice-cream cakes) and Soda. Any other items must be approved prior to the event by management.

Decorating: Families must provide their own decorations. All decorations must be approved by management. **Only the provided tables can be decorated.** No confetti, no latex balloons, glitter, piñatas or other decorations which create a clean- up issue are allowed. A cleaning charge will be assessed if the event space is not respected.

Damage: Any damage to property resulting from the direct action of the patron or their guest is the responsibility of the patron.

Clean-up: All items taken in must be taken out. We will provide a trash barrel to help with your clean-up.

Scheduled time: Patron agrees to begin the party at the scheduled time and agrees to vacate the pool area at the closing time as agreed. The patron agrees to reimburse The Inn at Scituate Harbor for any wage payments or other expense incurred due to patron's failure to comply.

Please note the pool is not closed to our Inn Guests and members during your time slot.
