2) Member moves to a location more than twenty five miles from The Inn at Scituate Harbor. In the event of lawful cancellation, the unused portion of the membership fee will be refunded on a prorated basis.

**Membership Agreement:** I hereby acknowledge that I have read and understand the rules and regulations applicable to this membership. I do agree to conform to and abide by said rules and regulations applicable to this membership.
